You will learn your responsibilities to perform all functions for shipping Hazardous Materials according to the regulations:

**49-CFR** (Domestic, UPS, FedEx, BOL, Decs) - **INT'l Air** (Int'l Air, FedEx, UPS, Decs \*FedEx requires Int'l Air for Domestic air) - **IMDG** (Int'l by vessel)

**COURSE METHODOLOGY:** Courses are taught using a combination of lectures, visual aids, work projects, and question & answer sessions. Students will learn a 7-step procedure for shipping HAZMAT. Upon passing a written exam participant receives a certification of accomplishment, meeting DOT/PHEMSA 172.700 subpart H, Int'l Air 1.5, and/or IMDG 1.3 requirements.

**Course Cancellation & Rescheduling Policy:**

**Within 14 days (2 weeks)** prior to date: a fee of \$230 for 2-Day or 1-Day courses & \$330 for 3-day course. **Within 7 days (1 week)** prior to date: a fee of ½ the cost will be assessed. **Within 2 Business days** prior to date: a fee of ¾ the cost will be assessed.
